

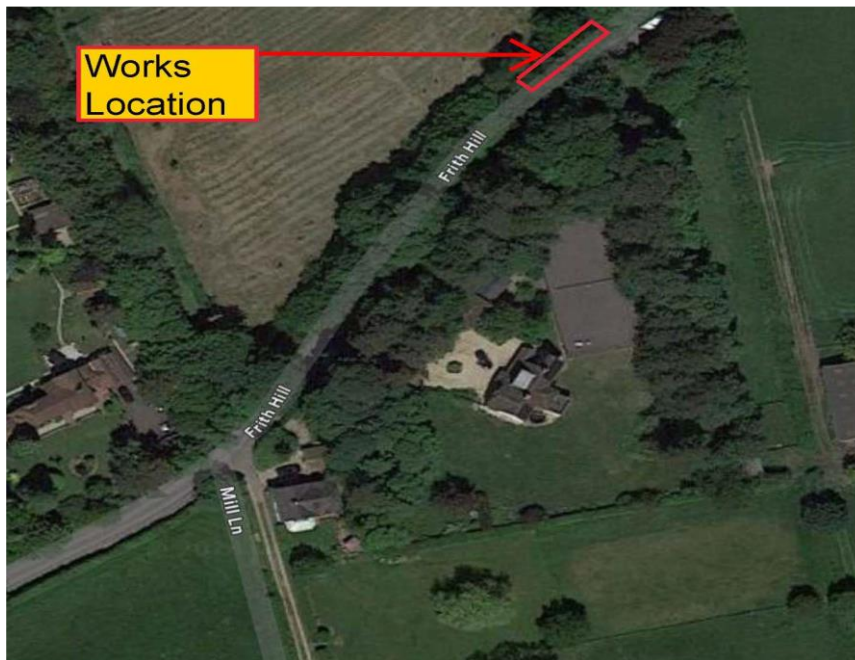
Single lane closure on Frith Hill, Great Missenden

High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of some works on Frith Hill that will require a single lane closure.

What are we doing?

UK Power Network (UKPN) will be conducting works to test existing underground cables on Frith Hill and to provide power to our North Portal site. This will necessitate a single lane closure of Frith Hill which will be managed with temporary two-way traffic lights to ensure traffic flow is maintained and minimise disruption. These activities will be undertaken in two separate stages of work across the coming months. Please note that UKPN will send out their own notice prior to these works. These works are not being carried out by Align JV.
