High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

We will be constructing an access to our working area and completing surveys along Cappers Lane. We will undertake vegetation management at this location while constructing the access. We will also complete utility surveys that will require small excavations to establish where utilities and services are located beneath the road surface.

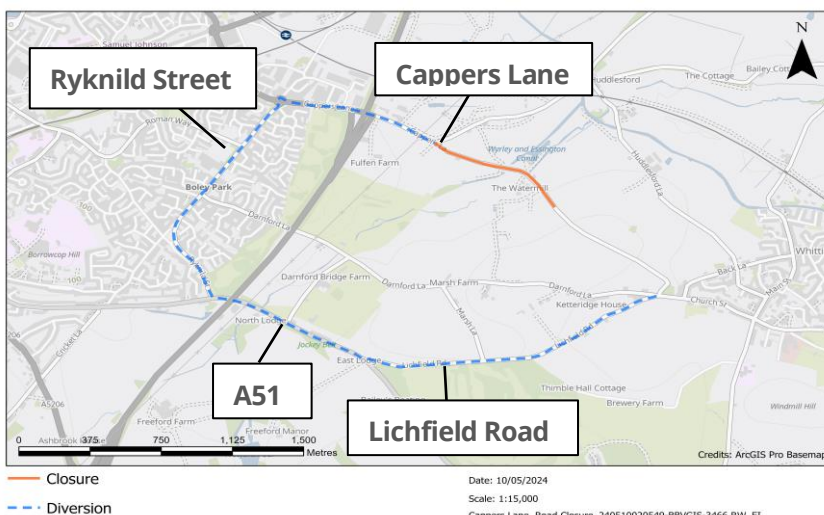
When the work will take place

From the 3 June to 30 September 2024, we will be delivering earthwork material that will be stockpiled at our Cappers Lane compound. The deliveries of materials to our site will be from 8am-6pm.

In addition we will require a closure of a section of Cappers Lane from 3 June to 7 June 2024. The road will be closed from 9:30 am to 3:30 pm.

Delivery of materials from 3 June until 30 September

Our working hours will be 8am-6pm (Monday-Friday).

Temporary closure of a section of Cappers Lane from 3 June until 7 June 2024.

Our working hours will be 9.30am to 3.30pm (Monday-Friday).

Our workforce can be on-site one hour before and after to set up and secure our equipment.
