High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As part of preparatory works for utility diversions on Ashow Road in June, we will need to carry out a number of survey works.

The surveys will involve our teams working on the carriageway. To ensure their safety and that of the public, we will have temporary traffic lights in place.

When the works will be taking place

The works will be carried out on the evening of 23 May 2024, to minimise local disruption there will be temporary traffic lights on Ashow Road B4115, these will be in place from 6pm to 10pm.

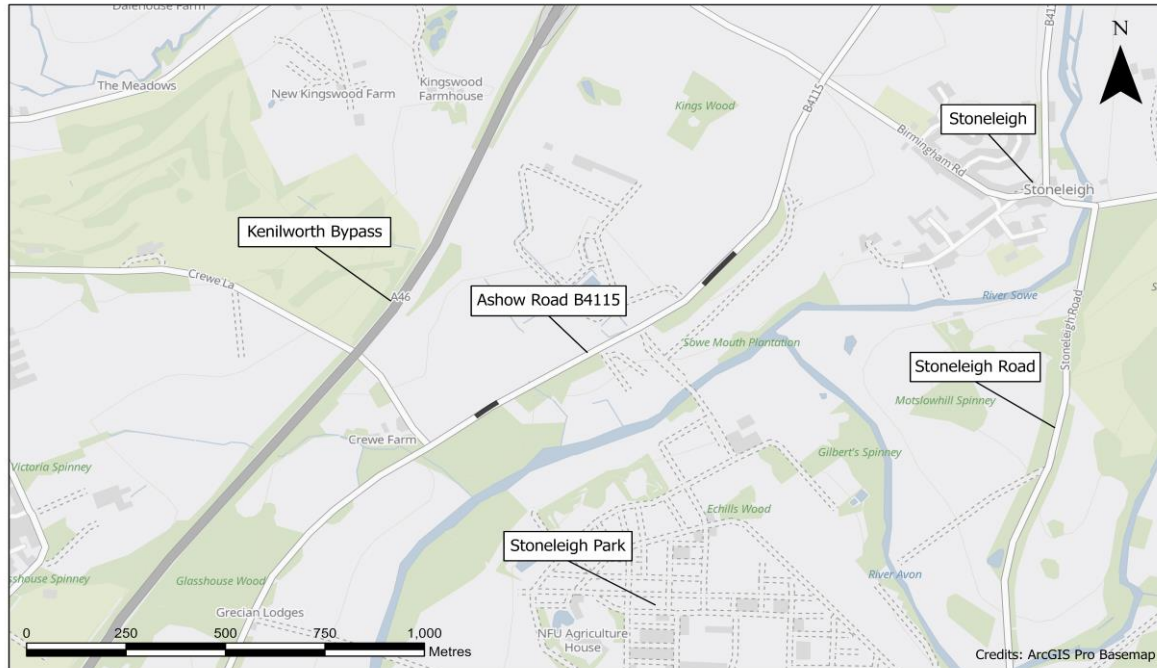

Temporary Traffic Lights

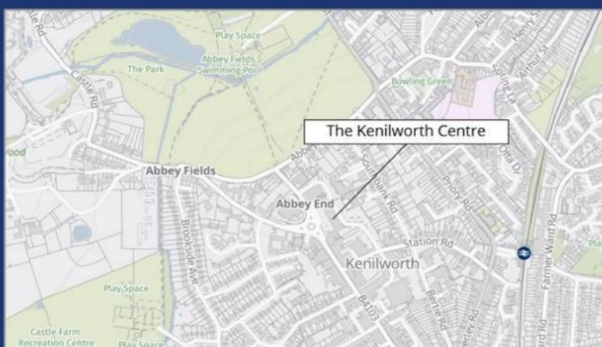


— Line of Works
