High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Demolition of Maria Fidelis Old School external brick wall

Our works undertaking the refurbishment of the Maria Fidelis Old School are progressing well. Our next stage of work includes the deconstruction of the single-story extension building which includes the removal of the brick wall along North Gower Street. This will be followed by the installation of new foundations and drainage connections.

These works will take place from **Wednesday 3 July 2024 until the end of July 2024**, between **8am and 5pm Monday to Friday** as detailed in the table below.

Location of works shown in orange	Description of works
	3 July 2024 – 1 week Removal of the external wall
	10 July 2024 – up to 3 weeks Foundation and drainage installation. Please note: this work includes the breaking of existing concrete slabs which will generate noise.

We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, **but please be aware the timeframe given above is a guide and that poor weather may mean the timings can change.** If these changes are likely to cause any disturbance, we will write to you again.

Duration of works

- From 3 July 2024 for four weeks, 8am to 6pm
- Start-up and close-down activities up to one hour before and up to one hour after working hours above

What to expect

- Works will take place in existing hoardings
- Pedestrian access will be maintained
- Noisy works at times

What we will do

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure
