

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Scaffold Construction

From **Saturday 22 June until Sunday 23 June 2024 between 8am and 4pm** we will be installing new scaffolding on the Maria Fidelis Old School building.

Traffic Management on the pavement and the road is not needed for this work, however, please note that we do expect these works to generate noise at times.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, **but please be aware the timeframe given above is a guide and that poor weather may mean the timings can change.** If these changes are likely to cause any disturbance, we will write to you again.

Duration of works

- 22 to 23 June 2024, 8am – 4pm
- Start-up and close-down activities up to one hour before and up to one hour after working hours above
