## What we are doing

From 14 June 2024, we will be working to prepare part of Ruislip Golf Course for reopening to the public. The area is adjacent to Hill Lane and Clacks Lane and is shown on the map overleaf.

Our works will include:

- grass cutting and removing overgrown vegetation within the field and along the fence line,
- performing an ecological check for any protected species, and
- removing fencing along the area using a forklift.

**We are aiming to reopen the area by the 15 July 2024.**
