## Update: Utility works on Brunswick Road and Lynwood Road

High Speed Two (HS2) is the new high speed railway for Britain.

#### **Ongoing works: West Gate Gas Diversion**

We wrote to you in May to update you on the utility works on Brunswick Road.

These works are to protect the gas mains below the road.

The current phase of work is due to be completed by late June 2024. Work will then start on Lynwood Road at the junction with the A40. The work phases are outlined in the table below. Please note, the dates for these works may change.

Date	Work location
April to 25 June 2024	Brunswick Road closure at junction with Brentham Way
25 June to 12 August 2024	Lane closed on Brunswick Road at junction with Brentham Way. Traffic lights in operation.
8 July to 13 August 2024	Lynwood Road closed at junction with A40
13 August to 13 September 2024	Brunswick Road full road closure at junction with Brentham Way
16 September 2024	Allotment and footpath reopen

The dates are indicative, and subject to change. The work locations are indicated in red on the map below.


