High Speed Two (HS2) is the new high speed railway for Britain. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

In late June, we will be removing some tree stumps along a section of School End. For reasons of safety, so we do not disturb utilities located below this area, the team will be using a vacuum excavator to slowly remove layers of soil and vegetation.

As our staff will be working directly in the road and to accommodate the machinery, this section of road will be closed during the day.

We will work to reopen the road to reduce disruption as soon as possible.

When will these works take place?

A section of School End will be closed between 8.30am and 5.30pm on the following dates:

- Thursday 27 June
- Friday 28 June
- Monday 1 July

These dates may be subject to change due to circumstances outside of our control, such as weather. Access will be maintained for residents located within the closure area.

A section of School End will be closed between 8.30 and 5.30 on:

- Thursday 27 June
- Friday 28 June
- Monday 1 July

Our contractors may be on site for one hours' start-up and shutdown either side of these times.

Noise from plant and equipment used for the works.

Manage any environmental impacts, such as traffic and noise

Notice of daytime road closures, School End, Chetwode

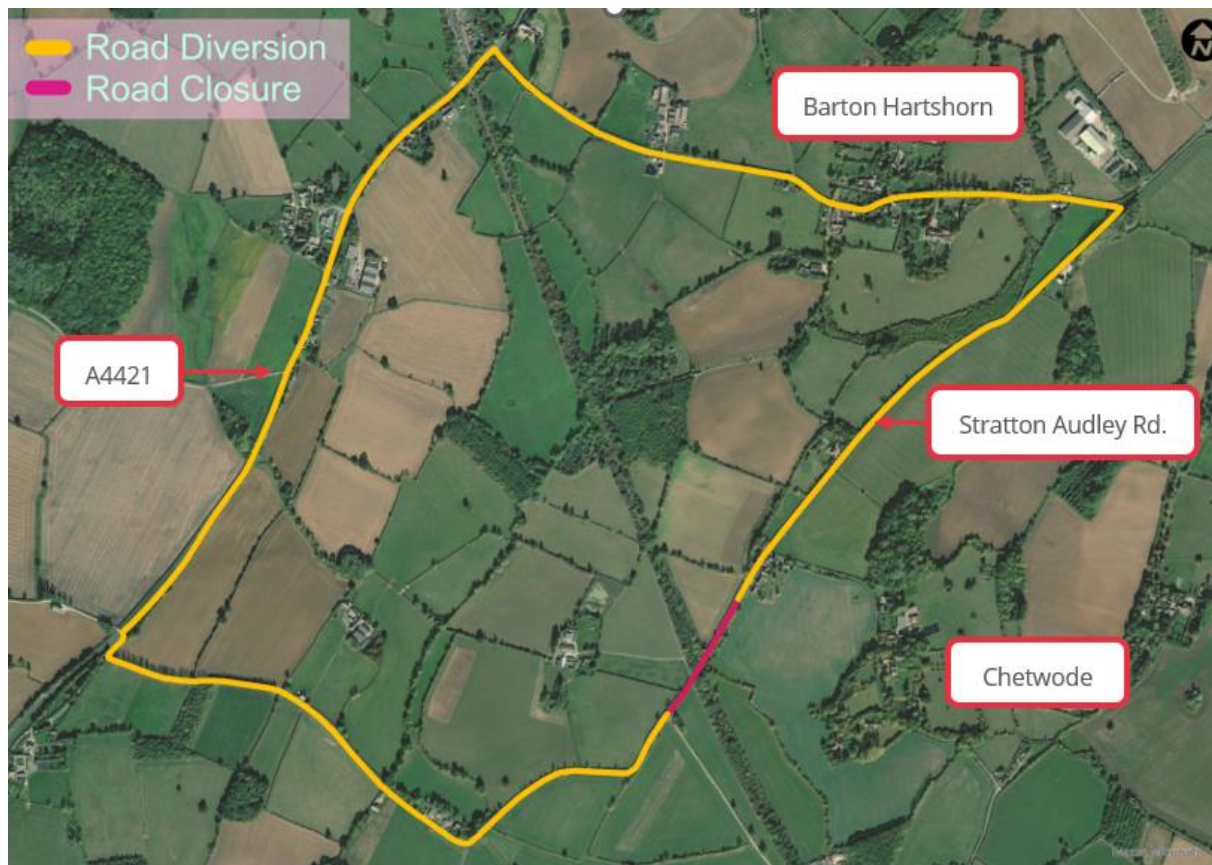
