High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Drummond Street Walkway Change

To assist in our utility programme the Drummond Street walkway will be realigned. From **Monday 3 June** these works will commence and are anticipated to take up to 7 days to complete.

Please note that pedestrian access to and from Euston Station will be maintained at all times during the works.

We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, but please be aware the timeframe given above is a guide and that poor weather may mean the timings can change. If these changes are likely to cause any disturbance, we will write to you again.
