High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do.

We recently completed works to temporarily realign Watling Street ahead of the upcoming construction of Watling Street Overbridge to allow the railway to pass underneath Watling Street. We are required to install road signage and prepare the area around the carriageway for further works. This will require the closure of Watling Street to complete these works safely.

When the work will take place

We will install a full closure on Watling Street to complete these works as follows:

- Watling Street, full closure **27** and **28 June** our working hours will be 9.00am until 4.00pm.

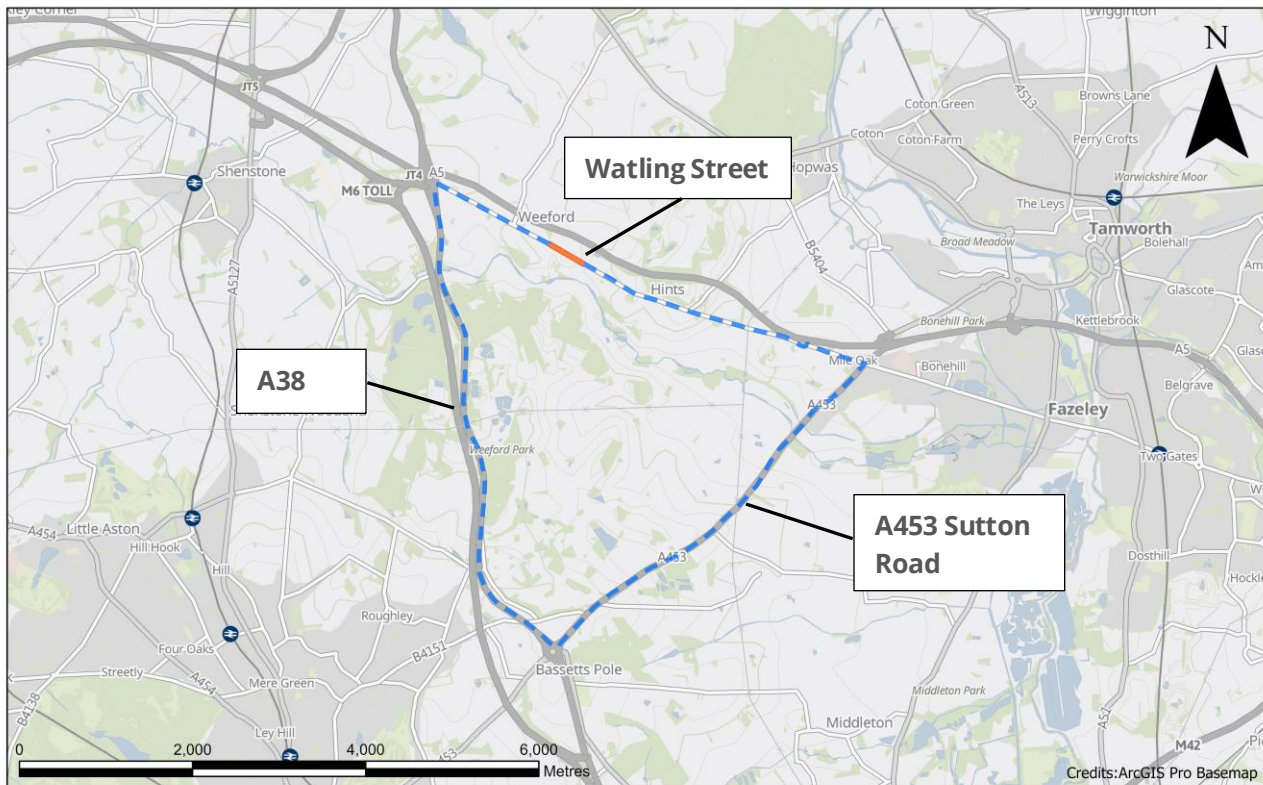
