



Notice of temporary lane closures on Faraday Avenue and A446 Southbound

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

As we progress with construction of the temporary diversion of Faraday Avenue, we wanted to provide you with an update on what further works are required to complete the next stages of this key activity, which will facilitate the building of HS2 structures in this location.

For the next stage of our works, we are proposing further daytime closures of two lanes which will be one lane on the Eastbound and one lane on the Westbound of Faraday Avenue immediately to the west of the Edison Road roundabout. This will be in place for a duration of approximately four weeks and will enable a 'crossover' to be formed in the location of the existing central reservation to facilitate safe working areas and implementation of traffic management systems for the next phase of works.

When the work will take place

To complete these works safely we will close two lanes, one lane on both east bound and West bound on Faraday Avenue and the A446 southbound as follows:

- **24 June** until **25 July 2024** between **7.30am** to **1.30pm** (Monday to Friday).

Access will be maintained for pedestrians.

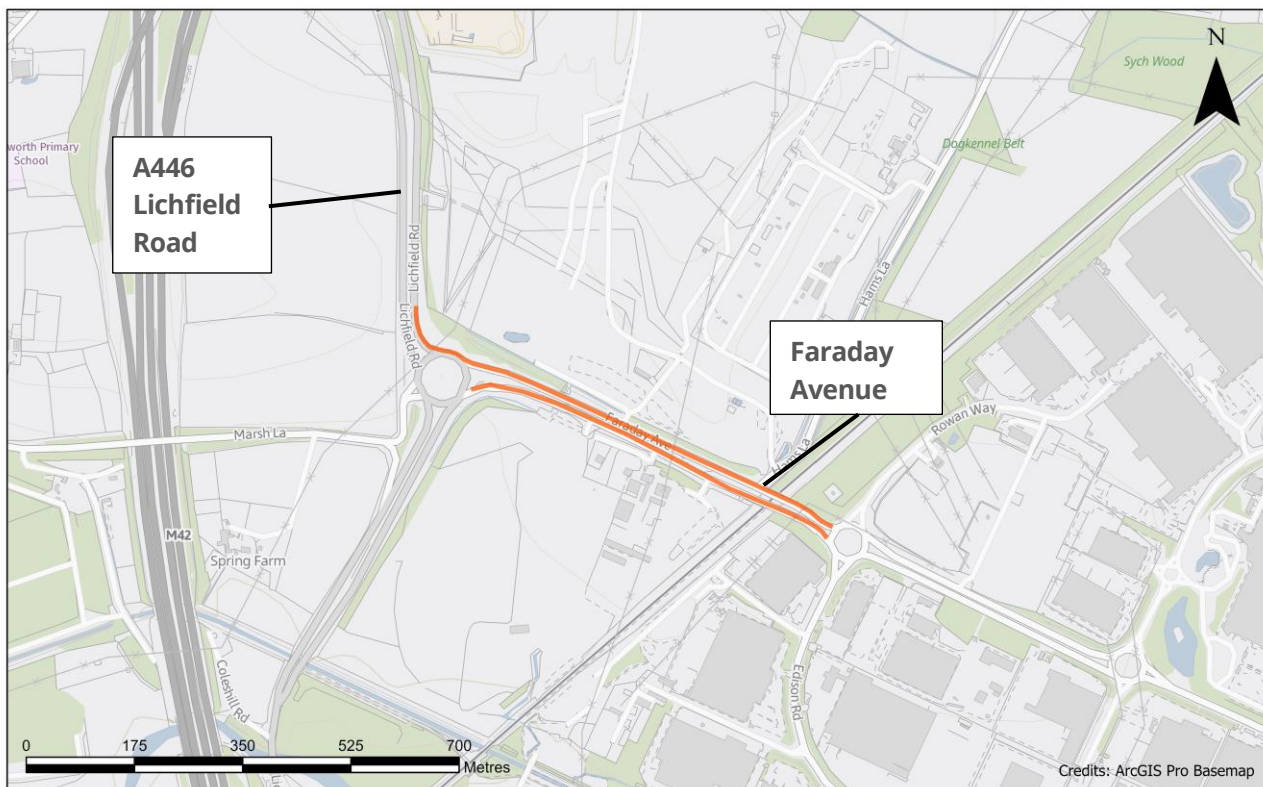
