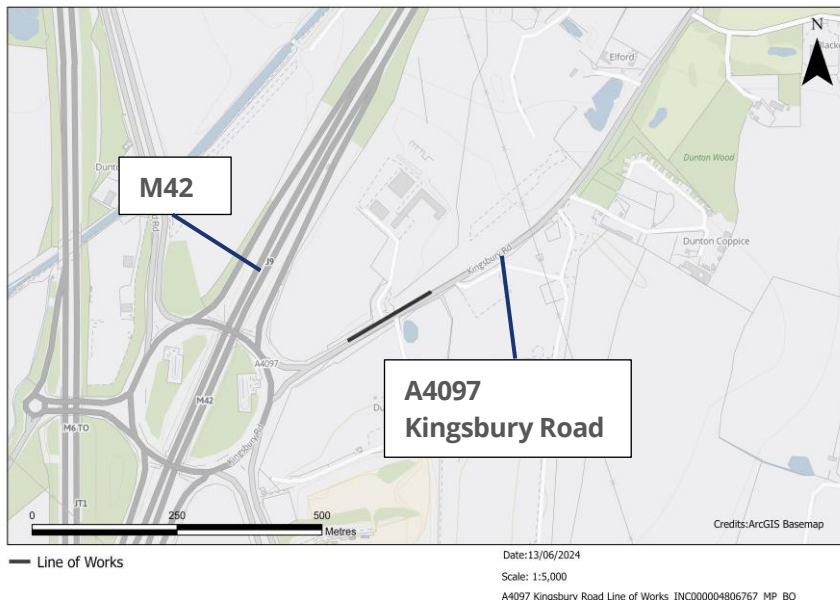
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will do.

We are required to undertake works as a matter of urgency to rectify a potential road safety issue on A4097 Kingsbury Road. We will need to establish a safe working area whilst our operatives are working on the carriageway. We will have temporary traffic lights in place for a short period of time whilst we complete these works.

### When the work will take place

We will install temporary traffic lights on A4097 Kingsbury Road on 20 June between 9pm until 11pm.
