



Road closure of Leather Lane. **Buckinghamshire**, for temporary traffic light installation

High Speed Two (HS2) is the new high speed railway for Britain. This notice is to inform you about a temporary road closure on Leather Lane, near Great Missenden / The Lee.

How will these works affect you?

Leather Lane will be temporarily closed to traffic from 8am to 4pm for one day, after which the traffic management will be removed.

Traffic will be diverted via Potter Row, Frith Hill, and Aylesbury Road (A413) during the closure. Please see the map on page 2.

The farmer's access will be maintained.

What will we be doing?

A small team will be visible in the highway whilst they carry out strimming of vegetation in the verges and trimming of protruding branches. They will then replace the established traffic lights on Leather Lane used in conjunction with the internal temporary access road, like for like.

HS2 commitments

HS2 has a commitment to Buckinghamshire Council which states that Leather Lane cannot be closed at the same time as Rocky Lane and Bowood Lane, unless the requirements have met the reasonably practicable request.

It is not safe to for our operatives to work in the single lane highway with live traffic. Leather Lane must be temporarily closed to traffic and cyclists while these works take place. This has been permitted and agreed by Buckinghamshire Council.

We apologise for any inconvenience that these works may cause to local residents and businesses. We will do everything we can to ensure that the works are completed on time and will lift the road closure as soon as we are able to.

- Maintain existing agricultural access from the western side of Leather Lane


