



Installation of a new temporary site office at South Heath, **Buckinghamshire**

High Speed Two (HS2) is the new high speed railway for Britain. This notice is to inform you that we will be setting up a temporary works compound and office next to the railway to facilitate our South Heath cutting earthworks.

What will we be doing and why?

A small team will be visible and working in the area whilst they set up welfare facilities, storage area, and a small car park. This is in readiness for us to begin piling works and earthworks movements for the South Heath cutting and adjacent landscaping. We will write to you with further information about this within the next few weeks.

The new compound will only be required for the duration of our works to landscape the area around the trace. The structure will consist of two floors and care will be taken to ensure that lighting and site security will be carefully controlled to reduce the impacts of this new compound.

The office will be used by up to 20 engineers and operatives.

What access route will you use?

Vehicles will use the A413 to Great Missenden, enter the North Portal access point, and will continue to the compound area using our already established temporary internal access road.
