



Updated notice for temporary closure of B4115 Ashow Road, Stoneleigh

High Speed Two (HS2) is the new high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are completing the final utility diversions and road realignment works which will connect to the new bridge on the B4115 Ashow Road.

These works will be completed under a closure of Ashow Road and two-way traffic lights at the junction of Crewe Lane.

When these works will take place

We recently communicated that we need to close Ashow Road (B4115) from Monday 18 August until Sunday 14 September. We have postponed the start of the works until September 2025.

Ashow Road (B4115) will now be closed 24/7 from **Monday 8 September 2025 to Sunday 5 October 2025**.

What to expect

There will be a **24/7** road closure in place on Ashow Road B4115 with temporary two-way traffic lights at the junction of Crewe Lane. You may notice increased levels of construction activity and some travel disruption. There will be a fully signed diversion in place to help drivers navigate their way.

Once these works are completed the new road will be open to the public.

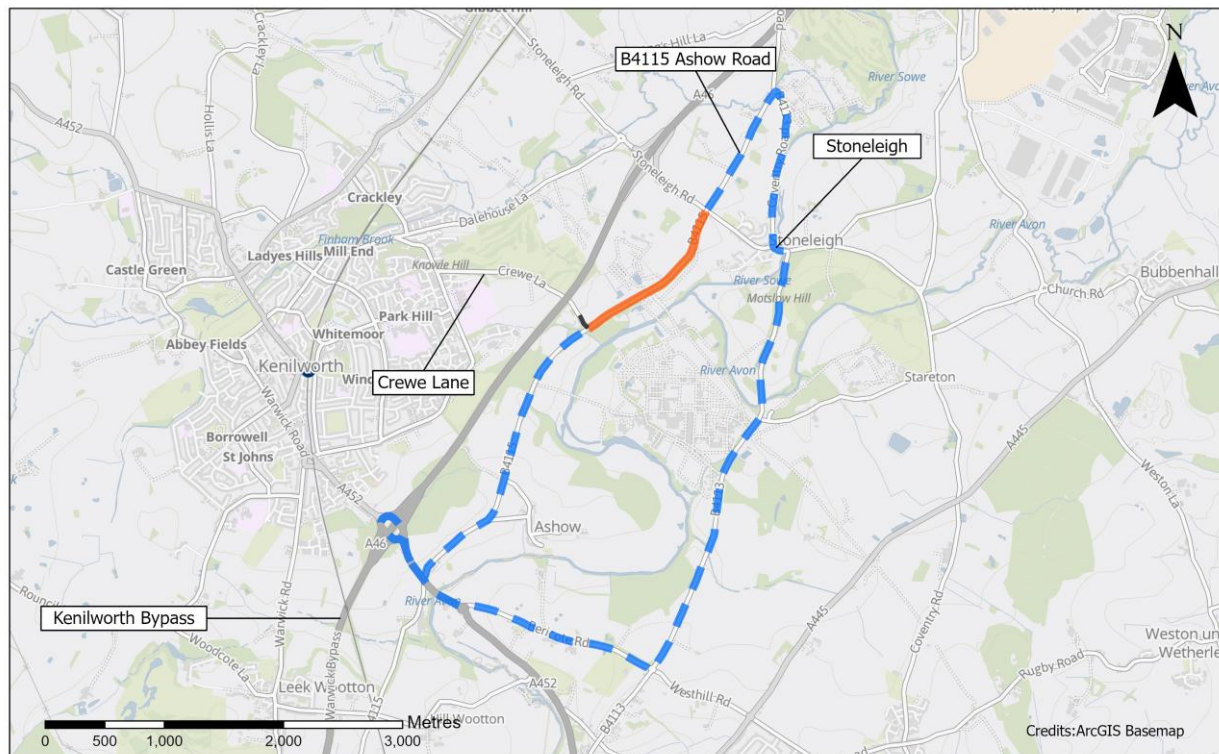
The diversion route

- talk to your local community engagement team about any queries you may have and community investment opportunities.



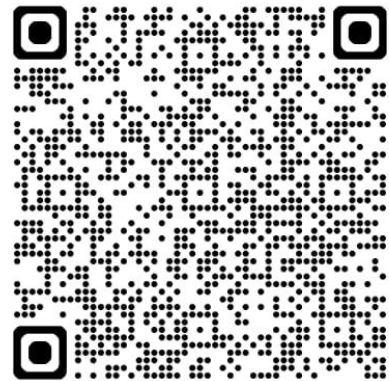
