High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be completing works on diverting utilities which enables final connections to be made. To complete these works safely we will be closing a short section of the filter lane on the A446 Lichfield Road at the junction of Gorsey Lane.

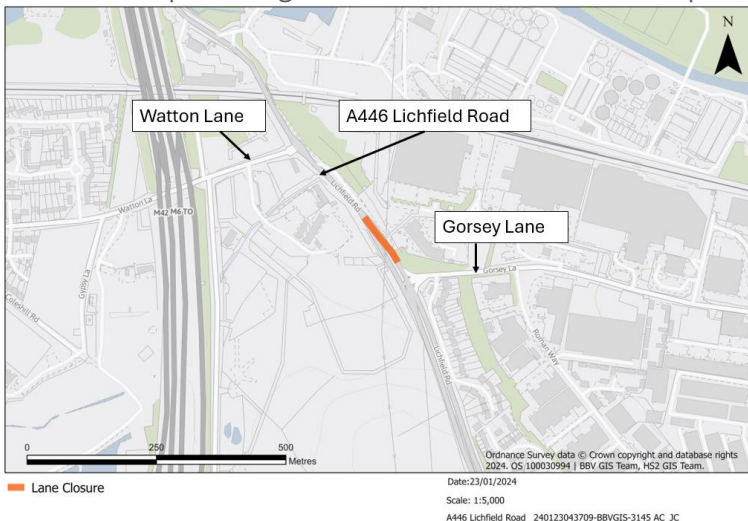
When the work will take place

UPDATED: Due to unforeseen circumstances, we need to extend these works to Friday 9 August. The lane closure will be in place 24 hours a day, 7 days a week.

Turning into Gorsey Lane will still be possible and the main lanes on the A446 will not be affected.

Duration of works

UPDATED: Temporary filter lane closure on the A446 Lichfield Road through to Friday 9 August 2024

Our working hours will be from 8am to 6pm each day

The lane closure will be in place 24/7 for the duration of the works

Our workforce may be on-site up to one hour before and after to set up and secure our equipment
