High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

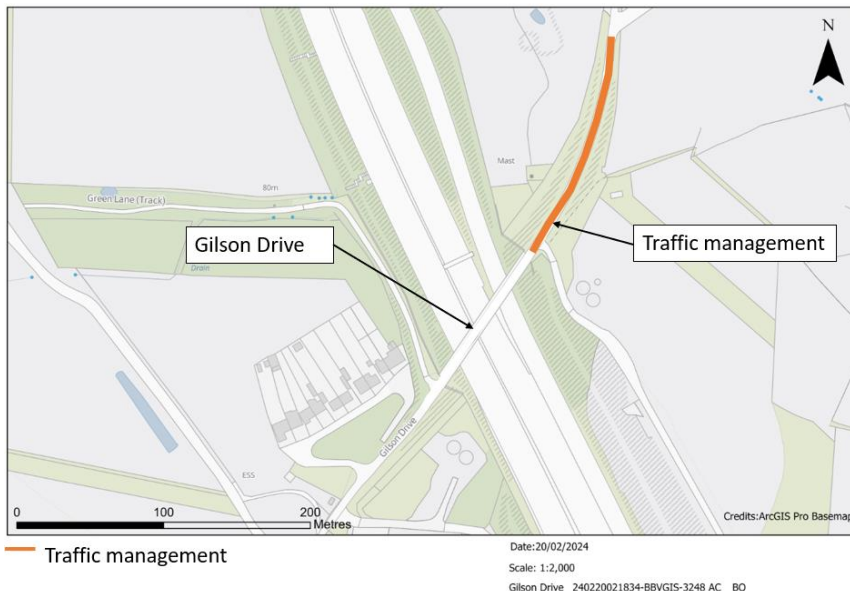
In order to prepare for our continued construction in the area, BBV will be undertaking utility works on Gilson Drive. The works include installing an electric cable across Gilson Drive. Once the cable is installed, we will install a passage underneath and reinstate the road.

When the work will take place

To ensure the safety of our workforce and road users we will be using stop and go signals to maintain access on Gilson Drive on Monday 5 August to Friday 9 August 2024.
