### What are we doing?

This summer, we will be continuing preparatory works ahead of our upcoming realignment of the A41.

We will be undertaking utility works, near the temporary roundabout to the west of Aylesbury. The work will necessitate a lane closure managed by temporary multi-signal traffic lights.

To reduce impact on road users, the traffic lights will be in operation at off-peak times and access will be maintained for residents along the A41.

### When will these works take place?

- **Monday 29 July – Friday 9 August, 9am-3pm**

Please note, these dates may be subject to change due to circumstances outside of our control but will be completed on or around the timings specified.

Should our team finish earlier than planned, we will open the road when practicable.

Access available for residents and pedestrians.

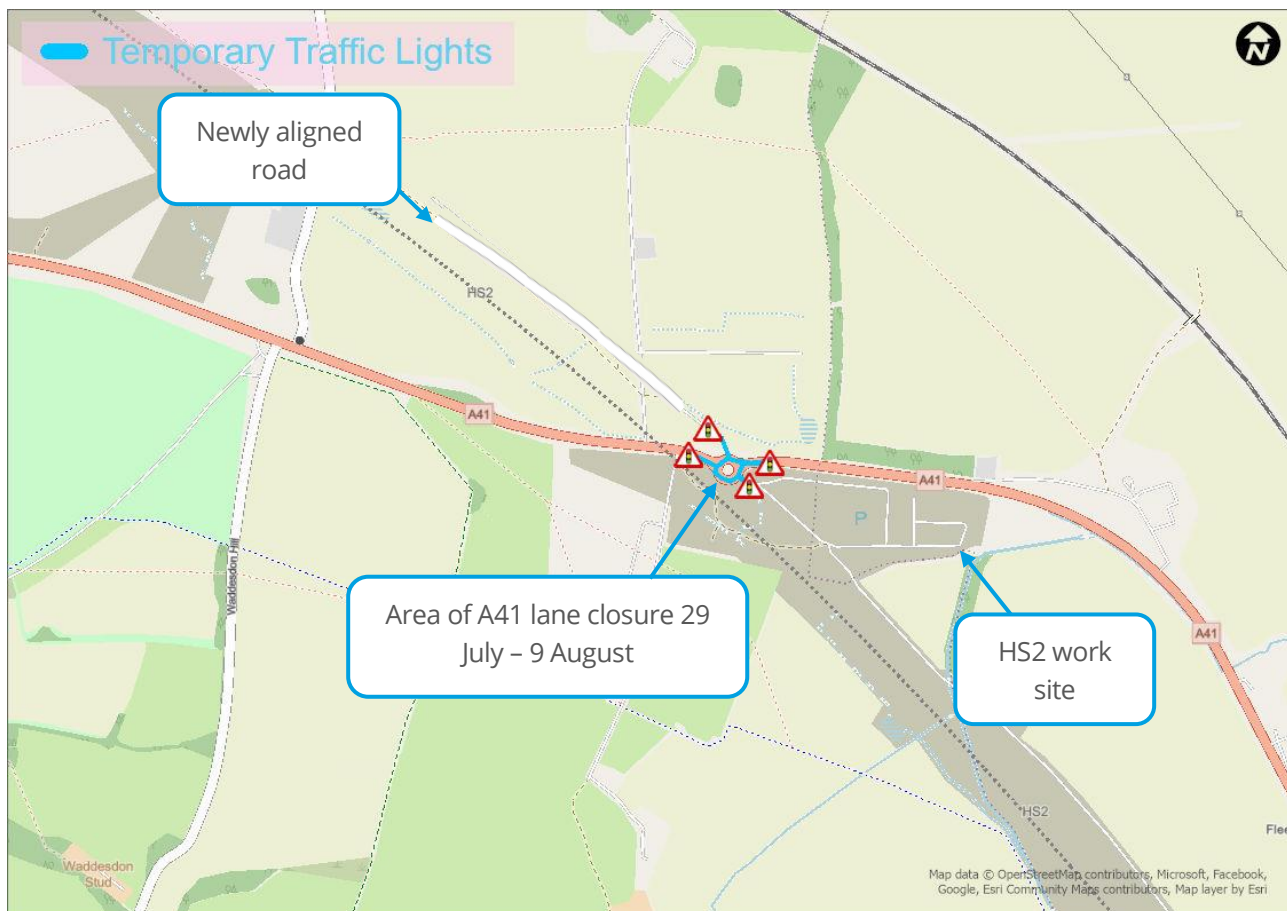

## How has Blackgrove Road been realigned?

In May, we completed the construction of the new northern roundabout of Blackgrove Road to connect it to the A41. The road has been realigned to allow the HS2 trace to pass. The southern section of Blackgrove Road (area highlighted in orange) will remain open for residents access but will no longer serve traffic.



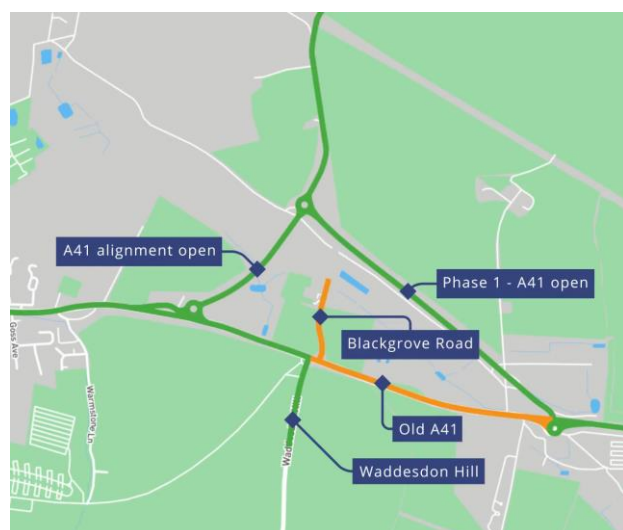
## Are there any more works on the A41?

Yes, there will be a section of the A41 that will be closed later this year (area highlighted in red). The road will be closed between Waddesdon and Waddesdon Hill for the next phase of construction. An advanced works notice will be issued to communicate the dates of the closures, including a diversion route for all road users.



## What will the next phase of the A41 realignment look like?

Following the completion of the first phase of A41 realignment works, we will be installing an additional roundabout at the west tie-in point. The section of the A41 between the temporary roundabout and Waddesdon Hill (area highlighted in orange) will undergo works at various points later this year and 2025. All closures and traffic management will be communicated through advanced works notices.
