Notice of traffic management on Bacombe Lane for verge works

What are we doing?

In July we are doing some devegetation works and a utility survey on Bacombe Lane, as part of our operations to construct the Bacombe Lane link road.

On Monday 22 July and Wednesday 24 July, there will be two-way traffic lights on the bend of Bacombe Lane. This is to ensure the safety of our operatives, who will be working along one side of the road and in the verges.

These works will begin at 9.00am to avoid impacting commuter traffic. They will finish by 6.00pm. To protect the safety of our team working close to the carriageway, one lane will be closed for the duration of our works.

Resident and pedestrian access will be maintained throughout the lane closure.

When will these works take place?

- Monday 22 July 09.00am 6.00pm
- Wednesday 24 July 09.00am 6.00pm

Should the works finish earlier than planned, we will open the road where practicable

These dates may be subject to change due to circumstances outside of our control but works will be completed in or around the set timeframes.

Manage any environmental impacts, such as traffic and noise.


