High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions or enquiries about our work, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

We need to carry out essential utility work to make an electrical connection to an underground cable to the verge of the A413 to the north of the junction with Rocky lane and in the vicinity of the petrol garage.

The utility partner has provided us with a window in which these critical works can take place and works are due to start on Monday 22nd July.

The works will be a combination of daytime and overnight works. Late night working is due to take place on Monday, Tuesday and Wednesday nights. We will be making every effort to minimise the amount of noise created by these works. The electrical supply to local residents and businesses will not be affected by these works.

To protect the safety of our team working close to the carriageway we will close the southbound lane of the A413 at night. During the day there will be operatives working on the verge, but no traffic management.

When will these works take place?

- Monday night, 10.00pm until 5.30am lane closure
- Tuesday daytime, 8.00am until 6.00pm
- Tuesday night, 10.00pm until 5.30am lane closure
- Wednesday daytime, 8.00am until 6.00pm
- Wednesday night, 10.00pm until 05.30 lane closure
- Thursday night contingency if required

These dates are subject to change due to circumstances beyond our control but will be completed in or around the anticipated time schedules. Should we finish the works early, the traffic management will be removed.

Take care to respect the community.




