

Amersham site, tower crane removal

High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of upcoming works at our Amersham vent shaft site which require a road closure.

What are we doing?

We will begin to dismantle and remove the tower crane at our Amersham vent shaft site from 5:30am on Saturday 10 August 2024. This crane was used to construct the vent shaft and is no longer needed on site. Works will continue across the weekend and are expected to be finished by 8pm on Sunday 11 August. To carry out the removal of the crane safely, a full road closure of Whielden Lane between Whielden Street and A404 will be implemented. Access to Amersham hospital for all vehicles will be via Whielden Street only during the closure. Buses will also be diverted route for the duration of these works. Pedestrian access will be maintained along Whielden Lane and will be facilitated by traffic marshals.

Works will begin at 5:30am on Saturday 10 August and continue through to 8pm on Sunday 11 August

Road closure on Whielden Lane from Whielden Street to junction with A404

Restricted access to Amersham hospital via Whielden Lane only

Traffic management and signage to guide pedestrians and vehicles during road closure
