Updated Notice -of traffic lights on Ashow Road and Crewe Lane, **Stoneleigh**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We previously informed you of works taking place at the junction of Ashow Road and Crewe Lane, under temporary three- way traffic lights. As part of our work, we have discovered uncharted utilities that have complicated the work. This means we now need additional time to complete our work. Works are now scheduled to be completed by **Friday 4 October**. We will continue to have advanced warning signs placed on B4115. See map below. The temporary three- way traffic lights will be in place from 8am to 6pm each day.

What to expect

There will be three-way traffic lights along the B4115 and you may notice increase levels of construction activity and minimal travel disruption.
