High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To prepare for our continued construction in the area, BBV will be installing two road crossings and electric cables on Attleboro Lane.

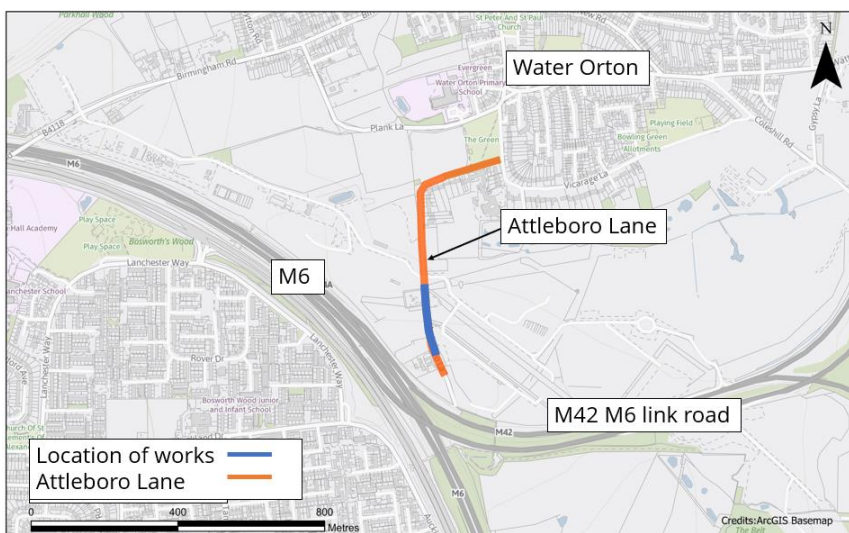
When the work will take place

To complete the works safely, we will install traffic management from 22 July to 2 August. The traffic management will be in place 24 hours a day, seven days a week. Our working hours will be from 8am to 6pm.

Access to properties will be maintained at all times.

Temporary road closure from 22 July to 2 August 2024
