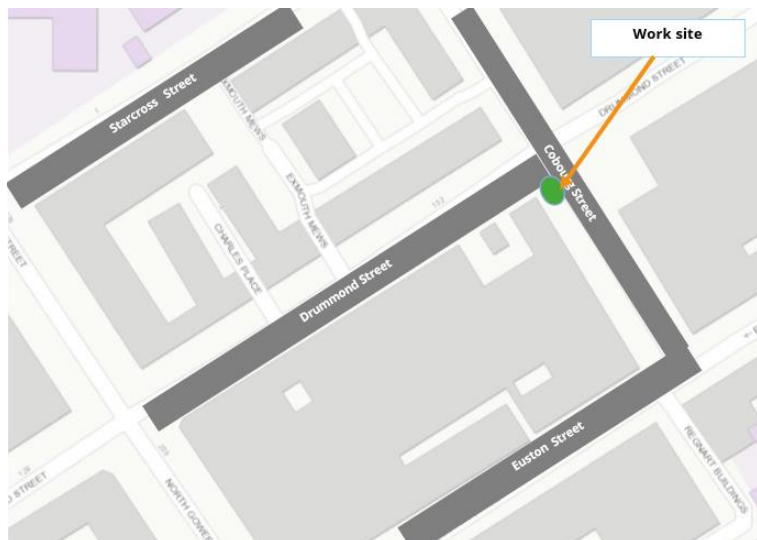
High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Ongoing closure of Cobourg Street footpath

To facilitate our ongoing utilities works **Cobourg Street footpath** will remain temporarily closed **until approximately September 2024**. This is later than originally communicated due to delays with our works.

Timing of night works

From **Sunday 28th July 2024 until approximately mid-August 2024**, we will undertake cabling and coring at night **(between 10pm and 5am)**. We need to carry out **these works at night** when train services are suspended and power to the railway is switched off. This is to ensure the safety of our team working close to the live railway. There will be periods **when the works will generate noise however sound barriers will be used to minimise this**.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, but please be aware the timeframe given above is a guide and that technical difficulties may mean the timings can change. If these changes are likely to cause any disturbance, we will write to you again.

Duration of works

- Night-time 28 July 2024 to mid-August 2024, 10pm to 5am – Nighttime
- Start-up and close-down activities up to one hour before and up to one hour after working hours above

What to expect

- Temporary worksites where work is taking place
- Temporary closure of South Cobourg Street footpath

What we will do

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure
