High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

#### **Emergency repairs**

We will be carrying out urgent welding works on a section of Duddeston Mill Road Underbridge to support the construction of the new HS2 structures in the area. To complete these works, we will need to erect scaffolding along a section of Duddeston Mill Road.

#### **Temporary road closure**

In order to carry this work out safely, we will need to temporarily close a section of Duddeston Mill Road and a section of the footpath between Loverose Street and Network Park. The road and footpath closure will be in place from midnight on 19 July to 11.59pm on 3 August.

Pedestrian access and access to frontages within the closure will be maintained throughout.

Ensure that our work areas are safe and secure.


