High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

As we progress with construction of Bangley Lane accommodation overbridge we have several tasks to complete to get our working area set up as safely as possible. This will require a two-week closure of Bangley Lane where our works will include stabilizing the piling area, removing tree stumps. Once this has been completed, we will begin piling works which will involve drilling into the ground and filling with steel and concrete to ensure the stability of the ground ahead of construction works to construct the overbridge. During these works we will have vibration monitors in place to ensure we stay within permitted levels.

When the work will take place

We will install a full 24-hour closure of Bangley Lane from 13 August until 27 August.

Our construction works will begin 13 August until 31 October 2025. Our working hours will be 8am to 6pm (Monday to Friday) and 8am to 1pm Saturday when required, with an hour before and after to set up machinery and to secure the working area.

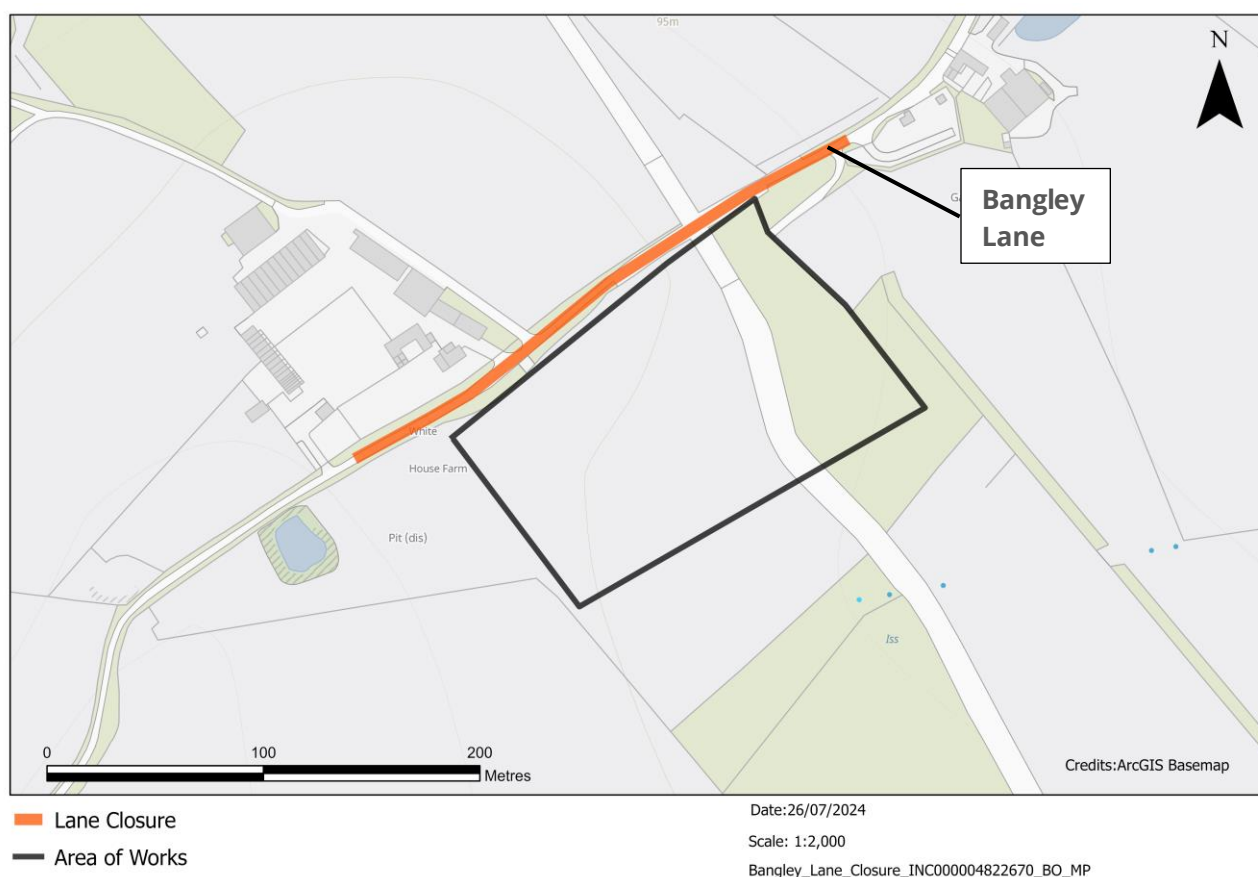
