
The work we are completing

We recently created a temporary diversion on the A453 Sutton Road; to allow for future construction works, this will enable the new railway to pass underneath A453 Sutton Road. The new temporary diversion will minimise impact on the road during construction.

To enable us to complete these works we will require temporary overnight traffic management on A453 to complete installation of permanent traffic signage and to conduct surveys.

When the work will take place

To minimise disruption, the work will take place overnight. We will have temporary traffic lights in place between **8pm** and **6am** from 13 August until 14 August 2024. Due to the nature of our works these lights may be moved along the road to ensure a safe working area.
