
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

# The work we are completing

We are to begin works to construct Church Lane Overbridge which allow the new HS2 railway to pass underneath Church Lane. We will be preparing the works area which will include earthworks, piling and moving machinery onto our site on Church Lane. This will require the use of the plant crossing on Church Lane from 29 July. We will also be carrying out surveys which will require the temporary overnight closure of Church Lane. Our works to complete Church Lane Overbridge will be completed in 2026.

# When the work will take place

To minimise disruption, the temporary road closure will take place overnight between 8pm and 6am from 5 August until 8 August 2024.
