# **Notice of overnight** closures on A38 southbound at Streethay

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.


### Work we are completing

We have started work on the A38 bridge that will enable HS2 trains to travel under the A38 at Streethay. In addition to this work, we need to carry out emergency works to clear some vegetation that is currently blocking road signage on the A38 southbound.

To ensure your safety, we need to close the A38 southbound carriageway while we complete these emergency works. You can see the diversion route below.

#### When the work will take place

The closure will take place over two nights from 6 August 2024 to 8 August 2024 and will be in place between 9pm and 5am. We may be on site one hour before and one hour after to set up and secure the site.
