



Notice of road closure for utility works on Hunningham Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed.

The work we will be doing

To progress the construction of Hunningham Road Overbridge we will be carrying out a utility diversion along Hunningham Road. The utility diversion works will be completed in four phases. During these phases we will complete surveys to locate the existing utility services and assess ground conditions. This will be followed by the digging of trenches, installing cables and completing connections and testing.

When these works will take place

These works will involve our teams operating in the carriageway. To ensure the safety of our workforce and the public we will install the following road closures:

Phase one: 31 July - 6pm – 10pm, full closure for one evening.

Phase two: 19 August to 13 September - full road closure.

Phase three: 21 October to 8 November - full road closure.

Phase four: 16 December to 20 December - off peak full closure between 8am - 6pm.

What to expect

You may notice increased levels of construction activity with some travel disruption.

Access for cyclists, pedestrians and frontages will be maintained throughout these works.

A signed diversion route will be in place for road users along B4455 Fosse Way (please see map on page 2).

Duration of works

To complete the utility diversion, we will require the following closures of Hunningham Road:

Phase one: 31 July - 6pm to 10pm full closure for one evening

Phase two: 19 August to 13 September - full closure

Phase three: 21 October to 8 November - full closure

Phase four: 16 December to 20 December - off peak full closure between 8am - 6pm

Our workforce can be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment

What to expect

Increased levels of construction activity with some travel disruption. Access for cyclists, pedestrians and frontages will be maintained throughout these works.

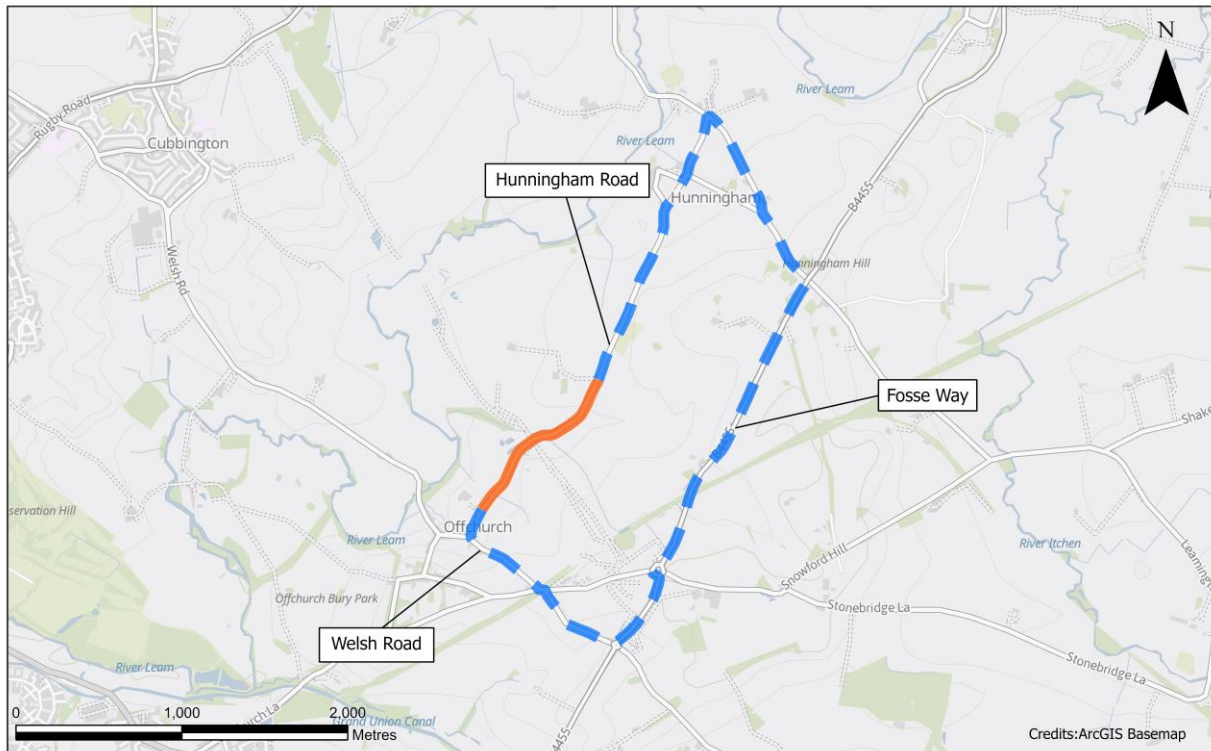

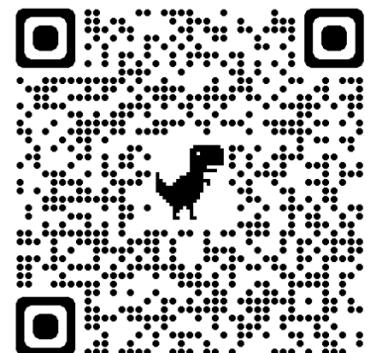
