What are we doing?

In July, we will be building a diversion to the footway alongside the A418 Oxford Road, near the Coldharbour Roundabout. This is in order to maintain pedestrian access during the upcoming road closures. These works will involve de-vegetation work and limited tree cutting to create room for the footway diversion.

Due to the proximity to the carriage way, there will be a lane closure for a short time under 3-way traffic lights for the safety of road users. This work is expected to be completed within 3 hours.

When will these works take place?

- Tuesday 9 July, 10am-1pm - 3-way traffic lights

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Provide updates for communities and maintain regular contact points for the duration of the work


