# **UPDATED: Notice of traffic** management on South Drive

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing


To continue our preparation for the construction of the HS2 railway, we will be undertaking works to temporarily divert South Drive. Once these works are completed, traffic will use the temporary diversion.

#### When the work will take place

**UPDATE**: The single lane closure and traffic lights will now be in place from Monday 22 July through to Thursday 22 August 2024. The traffic management will be in place 24 hours a day, seven days a week and our working hours will be from 8am to 6pm.
