High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

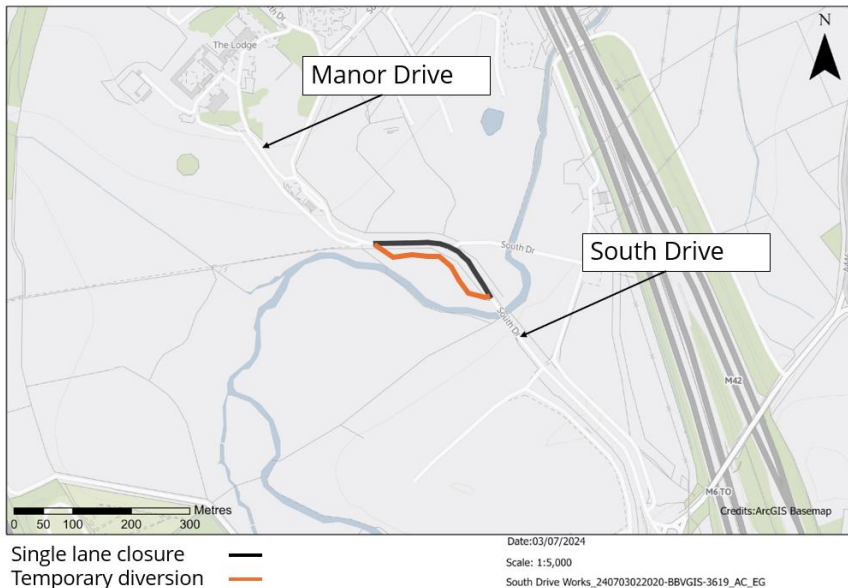
To continue our preparation for the construction of the HS2 railway, we will be undertaking works to temporarily divert South Drive. Once these works are completed, traffic will use the temporary diversion.

When the work will take place

To complete these works safely, we will install a single lane closure and traffic lights from 22 July to 12 August 2024. The traffic management will be in place 24 hours a day, seven days a week and our working hours will be from 8am to 6pm.

Duration of works

Temporary traffic management from 22 July to 12 August 2024.

Our working hours will be from 8am to 6pm each day

The lane closure will be in place 24/7 for the duration of the works

Low-level of noise from our machinery

Our workforce may be on-site up to one hour before and after to set up and secure our equipment
