A47 Aston Church roundabout utility works with partial lane closure

To support the construction of the new HS2 structures in the area, we will be carrying out critical utility works on the A47 roundabout at Aston Church Road.

We need to excavate deep into the existing carriageway to install new concrete BT ducts on the carriageway.

Partial Lane closure

To enable us to carry out these works safely and effectively, we need to partially close one lane on the A47 roundabout at Aston Church Road from Monday 2 September to Friday 6 September 2024.

Pedestrian access and access to frontages within the closure will be maintained throughout.
