High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We recently informed you of utility diversion works taking place at the junction of Ashow Road and Crewe Lane, under temporary three- way traffic lights. These phases have now been combined and will be carried out simultaneously.

When these works will take place

Works are now scheduled to be completed as a single phase of work from now until 23 September. To minimise local disruption, there will be advanced warning signs placed on B4115. See map below.

12 August to 23 September 2024 - temporary three- way traffic lights will be in place from 8am to 6pm each day.

What to expect

There will be three-way traffic lights along the B4115 and you may notice increase levels of construction activity and minimal travel disruption.


