High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we are completing

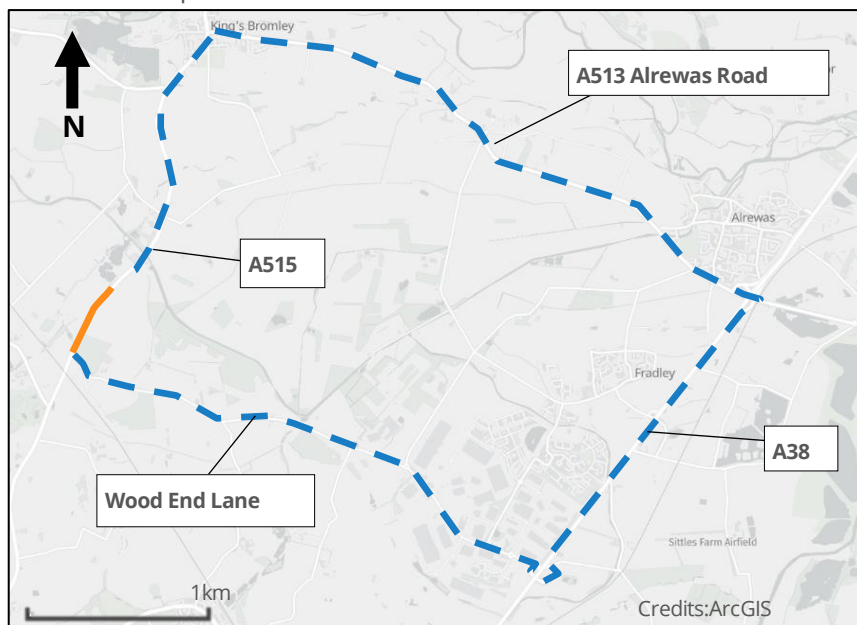
As we progress construction of the new HS2 railway we need to undertake survey works and vegetation clearance, along a section of the A515, from Wood End Lane to Kings Bromley Wharf. To ensure the safety of the public and our workforce we will install temporary daytime closures of a section of the A515.

When the work will take place

We will implement the road closures on **Monday 15 July to Friday 19 July**. Our construction team will be on site from 9:30am to 3:30pm. We have chosen these times to avoid peak travel times and to minimise disruption.

What this means for you

We will install a clearly signed diversion route during the closure periods. Please see map below.
