High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

On **Monday 18 November 2024**, we will be carrying out road reinstatement works on Bennetts Avenue. The works will include resurfacing a small area of the footpath and re-painting white lines on the road.

The traffic management will be removed from Bennetts Avenue once Thames Water have completed its works on Greenford Road.

How this might affect you

All works will take place within the existing site area and the road will remain closed for the duration of these works.

Handheld machinery will used to repair the footpath and repaint the white lines on the road.

Some of the footpath resurfacing works may be noisy and we will use noise reducing barriers where possible to minimise disruption to the local community.
