
What we are doing

From 19 to 24 August 2024, we will be removing a section of the concrete lining around one of the attenuation ponds within our Southern Sustainable Placement Area site on Breakspear Road South.

The removal of the concrete will enable access to complete the placement of soil at one of the mounds. The pond will remain in place to support water management on site. The location of the work is shown on the map below.
