What are we doing?

In September, we will be completing the second phase of our A41 realignment works to connect the road to the newly built roundabout near Waddesdon.

Prior to the realignment works, we will be undertaking utility works on a section of the A41 around Fleet Marston, between Waddesdon and Aylesbury. To carry out these works safely and effectively, the road will be closed for three consecutive nights. This is for reasons of safety, as our operatives will be working on and around the carriageway.

For our realignment works, the road will be closed between Waddesdon Hill and Waddesdon for 24 hours on three weekends in September, with one contingency weekend in October.

Access to properties along the A41 will be maintained throughout all closures.

When will these works take place?

- **Overnight road closures:**
 - Friday 6 September Monday 9 September, 8:30pm -5:30am
- 24-hour road closures:
 - o Friday 13 September 8:30pm Monday 16 September
 - o Friday 20 September 8:30pm Monday 23 September
 - o Friday 27 September 8:30pm Monday 30 September
 - o Friday 4 October 8:30pm Monday 7 October 5:30am (contingency weekend)

These dates are subject to change due to ground conditions but will be completed in or around the anticipated time schedules.

Take care to respect the community.






Where will the road closure be located and what is the diversion route?

The map below, shows the location of the overnight road closure between Friday 6 September – Monday 9 September.



The second map below highlights the diversion route for the road closure. When planning diversion routes, we have to allow for the use of like for like roads for all traffic users. This is to avoid sending vehicles down inappropriate routes for their size.









Where will the road closure be located and what is the diversion route?











