High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

In the coming weeks we are planning to carry out a series of verge maintenance with the installation of safety barriers along the highway. This will be carried out under a road closure.

To ensure the safety of our workforce and the public, we will install a road closure which will be in place for 24 hours each day, for the duration of the works.

When these works will take place

We will be closing Dalehouse Lane between Common Lane and Stoneleigh Road from **Monday 19 August to Friday 23 August 2024**.
The closure will be in place 24/7.

What will you expect?

There will be a signed diversion route in place during the closure. Access to all properties, for cyclists and pedestrians will be maintained throughout. See map below.

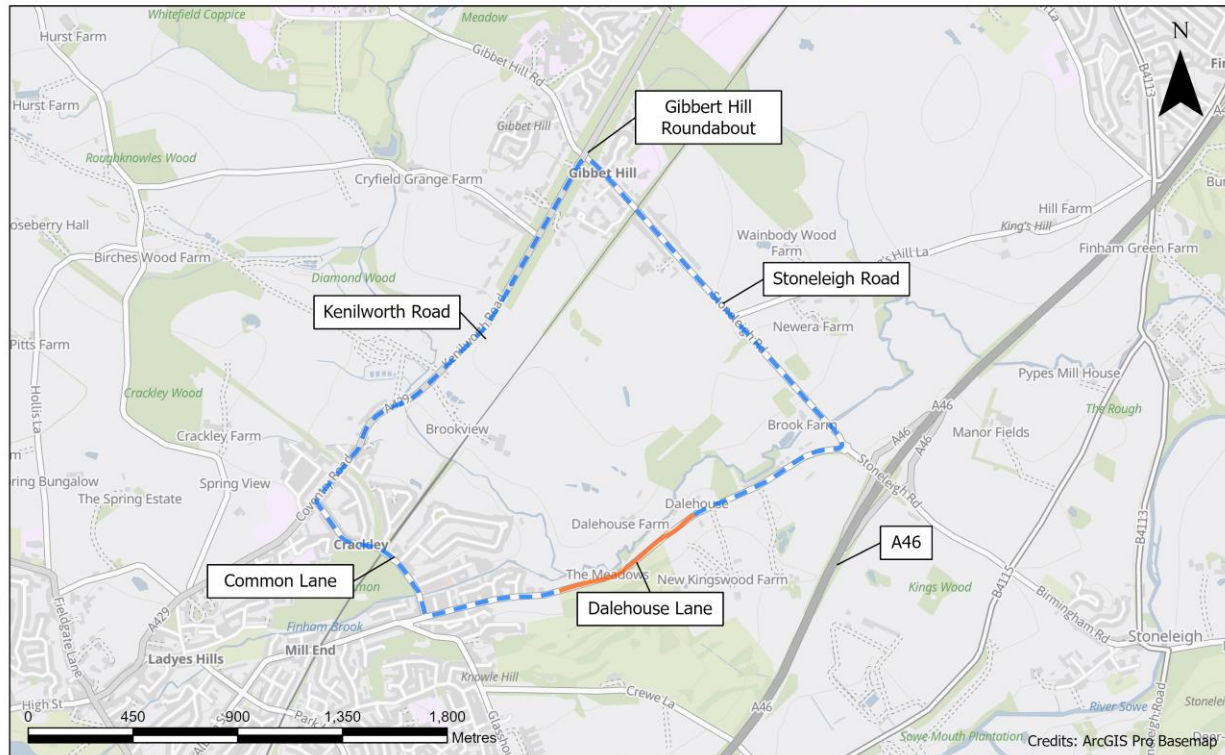

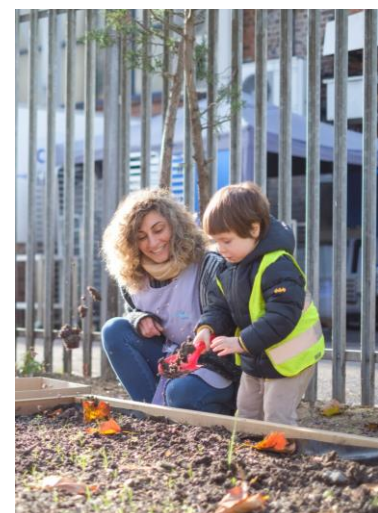
About our Community and Business Funds

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
