



Notice of M42 overnight lane closures, near Water Orton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To continue our works in the area, we will be undertaking works on the M42 between junction 7 and junction 8 in both directions. This is a continuation of works following the successful installation of the narrow lanes that have been installed to keep both workers and road users safe during the construction of the bridge structure in this location. The works required involve installing CCTV cameras to monitor the road for breakdowns and incidents as well as the removal of concrete gantry bases.

When we will do the work

To ensure the safety of the road users and our workforce, we will install overnight lane closures on the M42 between junction 7 to junction 8 in both directions. These lane closures will be in place from Monday August 19 until Friday August 23 and will be in place during the hours of 9pm to 5am.
