High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

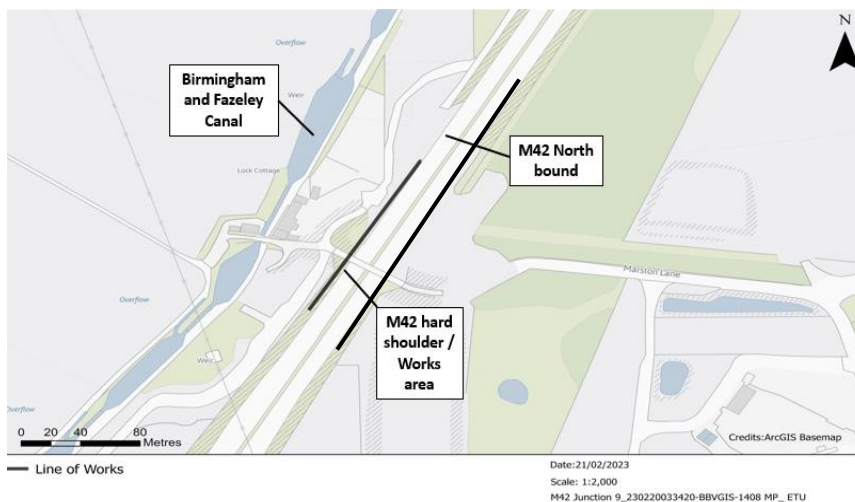
We have recently constructed the new Marston Box structure, a bridge that will take the HS2 line over the M42 motorway just north of Junction 9. We have further works to undertake on the bridge in order to complete the installation of the parapets.

To do this work safely we will need to close the hard shoulder of the M42 in both directions.

When will the work take place

We will carry out these works from **Monday 2 September** until **Friday 13 September**. The hard shoulder closure will remain in place 24 hours a day during this period.
