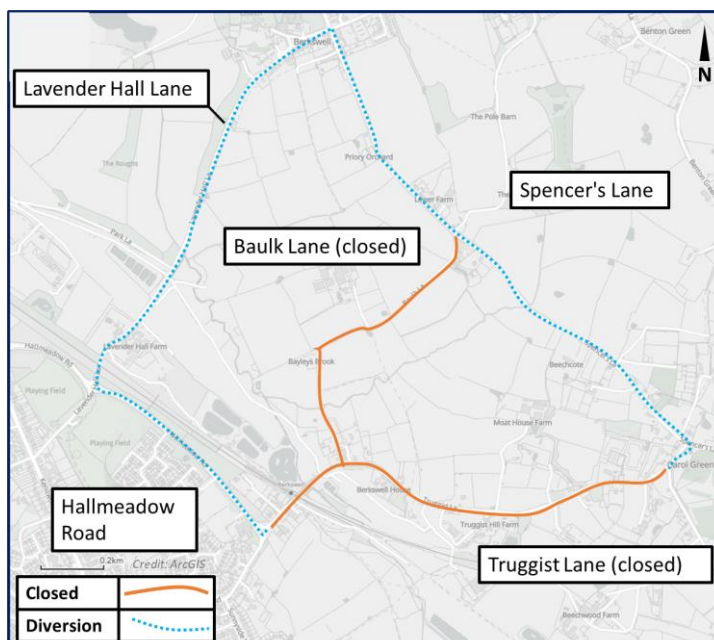

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

The new railway will pass over Truggist Lane on a viaduct structure. To protect the road during construction sheet piles will need to be driven into the verges on either side of the road. Sheet piling can be loud and disruptive. To minimise this disruption, we plan to pre-auger the existing ground which will significantly reduce the noise levels. To do this safely we will need to close the road from 9:30am until 3:30pm for 4 days from 2 September until 5 September.
