What are we doing?

In September, we will be completing the next phase of water main diversion works on the A4010 Risborough Road. During these works, a new section of pipe will be laid across the road requiring a road closure.

During the closure, we will also be undertaking routine inspections and maintenance of the temporary bridge on the A4010. The bridge must undergo inspection every three months and is currently being used for the movement of our site vehicles, reducing the impact of construction traffic on the A4010.

Due to the proximity of these works to the A4010 Risborough Road, there will be a full closure of a section of the road with a signposted diversion route. This is for safety reasons as our operatives will be working in and around the carriageway.

In order to complete the required work and reopen the road as swiftly as possible, we will be working 24 hours a day with consent from Buckinghamshire Council during this period.

When will these works take place?



- **24-hour road closure: Saturday 7 September (08:30) – Sunday 15 September (23:59) 2024**

These dates may change due to conditions outside of our control, but we will endeavour to complete them in or around the dates suggested above.

Where will these works take place?

The map below shows the section of the A4010 Risborough Road which will be closed from 7 – 15 September and the signposted diversion route.

Access for residents and businesses, including The Bucks Goat Centre, along the A4010 will be maintained via the signed diversions route. We have been advised that all of these businesses will be open as usual.

Access for pedestrians will be maintained through the closure.

Are there any more works on the A4010?

Yes, as we are progressing with the works in the area, there will be times where we will need to work in and around the carriageway which may result in temporary footpath closures, traffic management or some short-term road closures.

This will include working alongside our utilities companies to ensure that we are diverting and protecting the existing utilities which can include trial holes and other associated works.

We will also be progressing the construction of the relief road as the year progresses. The majority of this will happen 'offline' within the boundaries of our site and then we will work on what is referred to as 'tie in' sections to the existing highway.

What will happen to the road when the HS2 line is built?

The HS2 line will directly travel through the A4010. The structure itself will be elevated with and underpass access designed for pedestrians, bikes and other footpath users. The A4010 itself will be effectively stopped up and there will be no through road for other road vehicles.

The new relief road will serve the village of Stoke Mandeville and other road users and connect the A4010 up to Lower Road. The existing Risborough Road won't be closed until this new stretch of road is open to the public which is currently planned for 2025.
