



Notice of traffic management on A446 Lichfield Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be installing street lighting along a section of the A446 Lichfield Road at the junction with Gorsey Lane. To complete these works safely we will be closing the dedicated left turn from Gorsey Lane and the inside lane of the southbound carriageway of the the A446 Lichfield Road.

When the work will take place

The work will take place from Monday 16 September to Friday 11 October 2024. The left turn closure and lane closure will be in place 24 hours a day, seven days a week during the works.

Turning into Gorsey Lane will still be possible and the remaining lanes on the A446 will not be affected.

Temporary lane closures on the A446 Lichfield Road and Gorsey Lane junction from Monday 16 September to Friday 11 October 2024.

Working hours 9.30am to 3.30pm each day . The lane closures will be in place 24/7
