



UPDATE - Notice of overnight road closure on A452 northbound

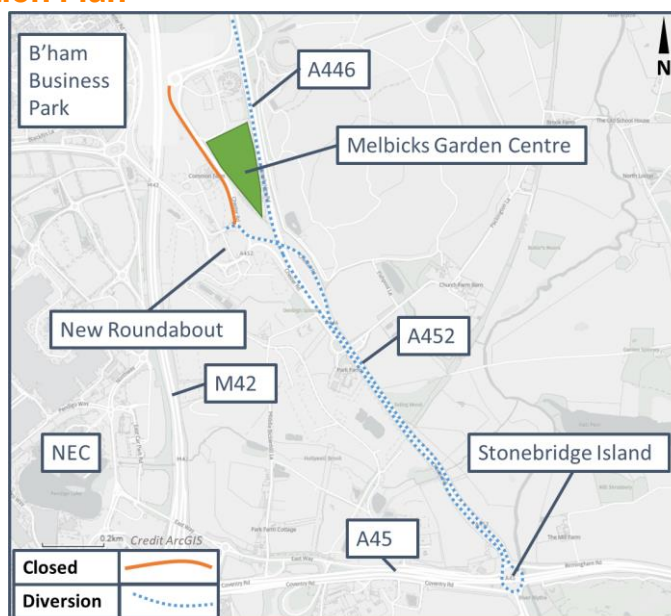
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

UPDATE – We previously contacted you to advise that the road will be closed on 17 and 18 of September to prepare the verge ready for the future installation of temporary safety barriers. We are now proposing to extend this closure until 20 September to install the barrier at the same time.

The work we will be doing

BBV have been significantly reconfiguring the junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park to facilitate the construction of a bridge that will take the new railway over the M42. This work is largely complete but before we can fully reopen both lanes of the road, we will need to install temporary safety barriers. Overnight, between 8pm and 6am from Tuesday 17 September until Wednesday 20 September, we will close the northbound carriageway of the A452 in front of Melbicks garden centre.
