

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Ongoing tempoary closure of Robert Street until early September 2024

We recently wrote to you (reference: HS2-MW-MD-Ph1-Ar-So-S1-Traf-37-25/07/2024) regarding works on Hampstead Road. These works require temporary closure of Robert Street. This is to ensure the safety of cyclists and how they interface with vehicles on Hampstead Road.

We recognise that Robert Street was reopened in error. To keep cyclists safe, **we need to keep a section of road closed to** vehicles. This closure will continue until UKPN complete their works on Hampstead Road. We expect **Robert Street to reopen early September 2024**

We recognise that construction work can be disruptive to those living and working nearby. We always try to complete works as quickly as possible, but please be aware the timeframe given above is a guide and that technical difficulties may mean the timings can change. We are working to reopen the road as soon as possible.
