This forward look covers HS2 associated work in Staffordshire.


The document is a forward look at construction activities planned for the next three months.

<b>Location 1</b>	Ongoing throughout 2024	<ul style="list-style-type: none"> <li>Preparatory works for A515 Underbridge including installing safety barriers on the road.</li> </ul>
<b>Area-wide</b>	Ongoing throughout 2024	<p>We are undertaking a range of surveys in this area, including utility, environmental and ground investigation surveys, which may require temporary traffic management. Our activity includes:</p> <ul style="list-style-type: none"> <li>Excavating 'trial holes'</li> <li>Locating existing utilities using Ground Penetrating Radar (GPR) surveys</li> </ul>

- Surveying existing ground levels
- Surveying water bodies
- Carrying out ecological surveys

## Map 2 - Whittington to Fradley





Location of works	Proposed duration	Description of works
<b>Location 1</b>	Ongoing throughout 2024	<ul style="list-style-type: none"> <li>• Building a bridge to hold the A38 in order to allow the new line to run beneath the main carriageway, slip roads and existing railway lines.</li> <li>• Phased traffic management to carry out this work safely. This began with the total closure of the A38 southbound slip road at Initiating a total closure of the A38 northbound slip road and lane closures on the carriageway in the Streethay area during later phases of work</li> </ul>

<b>Location 2</b>	Until Summer 2025	<ul style="list-style-type: none"> <li>• Darnford Bridge preparatory works, site set up and piling works due to start autumn 2024</li> </ul>
<b>Area-wide</b>	Ongoing throughout 2024	<p>We are undertaking work in this area, including utility, environmental and ground investigation surveys, that may require temporary traffic management. Our activities include:</p> <ul style="list-style-type: none"> <li>• Excavating 'trial holes'</li> <li>• Diverting utilities</li> <li>• Installing fencing</li> <li>• Translocating vegetation</li> <li>• Building haul roads and access points</li> <li>• Locating existing utilities using Ground Penetrating Radar (GPR) surveys</li> <li>• Surveying existing ground levels</li> <li>• Surveying water bodies</li> <li>• Carrying out ecological surveys</li> </ul>



Location 1	Ongoing throughout 2024	<ul style="list-style-type: none"> <li>Constructing the embankment at Whittington Heath Golf Club, including continuing vegetation clearance, installing additional security fencing, building haul roads</li> <li>A51 Tamworth Road Overbridge earthworks works and piling due to start in summer 2024 with completion due in 2025</li> </ul>

<b>Location 2</b>	Ongoing throughout 2024	<p>We are continuing our works on the A5 and Watling Street, including:</p> <ul style="list-style-type: none"> <li>• Work commenced in February 2024 with a temporary diversion, earthworks and piling works being competed ahead of structure being built</li> <li>• Installing speed cameras</li> <li>• Diversion of Watling Street to be completed by early 2026</li> <li>• Moving traffic onto the A5 temporary road</li> <li>• Installing safety barriers and surfacing the temporary road</li> </ul>
<b>Location 3</b>		<ul style="list-style-type: none"> <li>• Work commenced in February 2024 with a temporary diversion, earthworks and piling works being competed ahead of structure being built</li> <li>• From March 2024 to 2026 main works will start on the A5 overbridge</li> </ul>
<b>Area-wide</b>	Ongoing throughout 2024	<p>We are undertaking works here, including utility, environmental and ground investigation surveys. Please note that our works may require temporary traffic management. Our activities include:</p> <ul style="list-style-type: none"> <li>• Excavating 'trial holes'</li> <li>• Locating existing utilities using Ground Penetrating Radar (GPR) surveys</li> <li>• Surveying existing ground levels</li> <li>• Surveying water bodies</li> <li>• Carrying out ecological and topographical surveys</li> <li>• Dismantling properties</li> </ul>

<b>Location 1</b>	Summer 2024 to autumn 2025	<ul style="list-style-type: none"> <li>Bangley Lane utility works due to take place this summer as well as earthworks and piling works</li> </ul>
<b>Location 2</b>	Summer 2024 to early 2026	<ul style="list-style-type: none"> <li>Excavating to prepare for the temporary A453 Sutton Road diversion</li> <li>Beginning piling works to build A453 Sutton Road Overbridge</li> <li>Main works on the overbridge to start Spring 2024 with completion expected early 2026</li> </ul>

<b>Location 3</b>	Ongoing throughout 2024/25	<ul style="list-style-type: none"> <li>Ongoing works including bridge construction and utility works on Drayton Lane Overbridge to be completed by summer 2025</li> </ul>
<b>Location 4</b>	Until 2026	<ul style="list-style-type: none"> <li>Before we begin works to construct Church Lane Overbridge, we will be undertaking works to survey and divert underground utilities Temporary works. A plant crossing will be in use. (Earth works and pilling works this summer with a completion in spring 2026</li> </ul>
<b>Area-wide</b>	Ongoing throughout 2024	<p>We are undertaking works here, including utility, environmental and ground investigation surveys. Please note that our works may require temporary traffic management. ## Our Community Commitments

We aspire to be a good neighbour every single day, by respecting the people and communities we impact and being sensitive to their needs, earning our social licence to operate.

To build the railway, we must earn the trust and credibility to do so. We need to demonstrate that we understand local concerns and that we have taken all reasonable steps to address issues that have been raised, whilst continually looking to lessen the impacts of the project.

Through our Community Engagement Strategy and Residents' Charter, we have identified ten Community Commitments which we will use as the basis for measuring our success, and that of our suppliers, in how we deliver the new railway.

## We will:

1. Continue to build respectful, long-term relationships with communities and actively encourage our workforce to listen to local concerns and be considerate and accountable for their actions at all times.
2. Work with communities to develop local two-way engagement and communication programmes, ensuring they are accessible and tailored to local needs.
3. Make sure communities are made aware in advance of any activities taking place in their area.
4. Operate a Freephone Community Helpline 24 hours a day, 365 days a year.
5. Make health and safety a priority for communities and our workforce.
6. Respect the wellbeing of communities, minimising disruption to their lives with local mitigation plans and activities, ensuring we meet the standards set out in the Code of Construction Practice.
7. Leave a positive and sustainable legacy for the communities in which we operate.
8. Respond to questions and complaints quickly and efficiently, with an acknowledgement within two working days, and responding within a maximum of 20 working days if we cannot answer the query straight away.
9. Promote awareness of all our property schemes so that anyone who may be eligible has all the information they need and is aware of the support available to them.
10. Display the Residents' Commissioner and Construction Commissioner's contact details on all relevant materials, along with the HS2 Helpline information and complaints procedure.

The Code of Construction Practice forms part of the Secretary of State's Environmental Minimum Requirements for the construction of the railway from London to the West Midlands. It sets out the standards and responsibilities to protect communities and the environment during construction. A copy of the Code can be found online here:
