High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

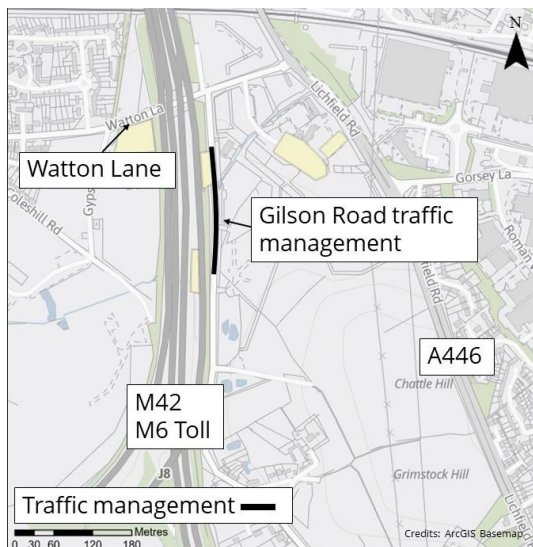
Emergency repair works to the carriageway surfacing. The integrity of the tarmac is disintegrating and when it rains there is a build-up of water creating potholes. Kerbs are also broken and loose. These will be removed and replaced with a reinforced concrete slab.

When the work will take place

UPDATED In order to carry out these emergency works safely, we will have a single lane closure from Monday 19 August to Tuesday 20 August. Manually controlled stop and go signs will be in place between the hours of 7.30am to 6pm each day.
