## **Notice of Melton Street footpath works**



High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

### **Melton Street Footpath Works**

From **Friday 20<sup>th</sup> September 2024, between 8am and 4pm** we will be carrying out remedial works on Melton Street footpath to remedy uneven paving slabs making it easier and safer for all pedestrians to navigate to and from Euston Station.

Works is expected to be completed by 24th September 2024. During these works, the footway will be closed with pedestrians being diverted to an alternative footpath adjacent to Melton Street. Site marshals will be available to help direct members of the public who may need assistance.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, but please be aware the timeframe given above is a guide and that technical difficulties may mean the timings can change. If these changes are likely to cause any disturbance, we will write to you again.

#### **Duration of works**

- 20 24 September 2024
- 8am 4pm

#### What to expect

- Reduced footway on Melton Street
- Pedestrian diversion route during working hours
- Marshals in place to assist pedestrians

#### What we will do

- Aim to reduce noise and vibration as reasonably practicable
- Apply dust mitigation measures
- Create temporary work sites
- Keep all sites safe and secure
